Notice is hereby given that the 25th Annual General Meeting (AGM) of the members of the Company for the financial year 2017-18 will be held on Wednesday, the 12th September, 2018 at 12:30 P.M. at ‘Rotary Sadan’, ‘S.S. Hall’, 94/2, Chowringhee Road, Kolkata – 700 020 to transact the business as set out in the notice of AGM dated 10th August, 2018 which has been dispatched to the Shareholders of the company along with Annual Report by permitted mode on 18th August, 2018.

Pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Section 108 of the Companies Act, 2013 and the Rules framed thereunder, the Company is providing e-voting facilities to the Members of the Company holding shares either in physical or in dematerialized form as on the cut-off date i.e. 5th September, 2018 to cast their vote electronically through e-voting services provided by Central Depository Services (India) Ltd. (CDSL) on all resolutions set out in the Notice of the AGM. Members are requested to note the following:

1. The Remote e-voting period shall commence on Sunday, 9th September, 2018 at 9.00 a.m.(IST) and shall end on Tuesday, 11th September, 2018 at 5.00 p.m.(IST). The remote e- voting module shall be disabled thereafter and voting through electronic mode shall not be allowed beyond said date and time.
2. Cut-off date: 5th September, 2018.
3. Any person, who acquires shares of the Company and become member of the Company after dispatch of the notice and holding shares as of the cut-off date i.e. 5th September, 2018, may obtain the login-ID and sequence number by sending a request to Niche Technologies Pvt Ltd., the Registrar & Share Transfer Agents (RTA) at nichetechpl@nichetechpl.com or to the Company at investors@dollarglobal.in.

However, if the member is already registered with CDSL for e-voting then such member can use his/her existing User ID and password for casting his/her vote.

4. The facility for voting through ballot paper shall be made available at the AGM and the members attending the meeting who have not cast their vote by Remote e-voting shall be able to exercise their right at the meeting through ballot paper.
5. A member may participate in the AGM even after exercising his right to vote through Remote e-voting but shall not be allowed to vote again in the AGM.
6. A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date only shall be

entitled to avail the facility of Remote e-voting as well as voting at the AGM through ballot paper.

7. Notice of the AGM and the Annual Report is available on the company's website i.e. www.dollarglobal.in and the website of www.cdslindia.com.

8. The Company has appointed Mr. Santosh Kumar Tibrewalla, Practising Company Secretary as Scrutinizer to scrutinize both the electronic voting process and voting process at the venue of AGM in fair and transparent manner.
